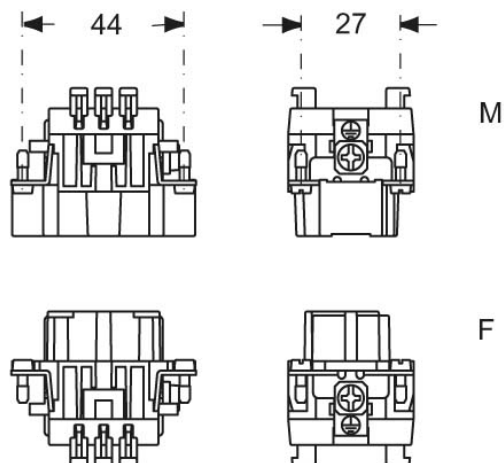

contacts side (front view)

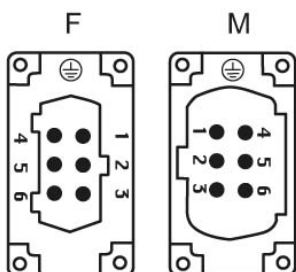
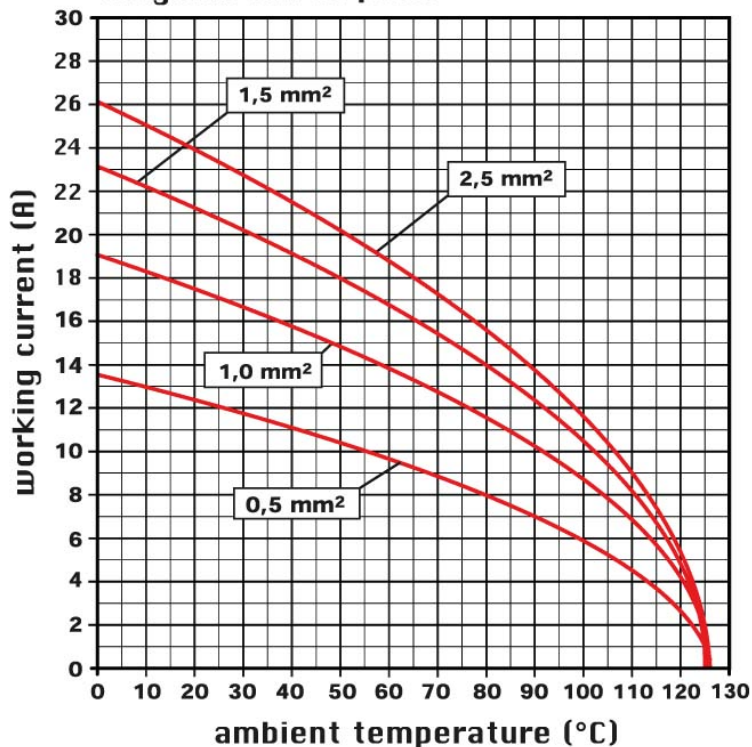


diagram CSH 06 poles

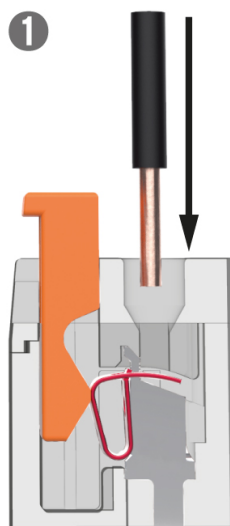

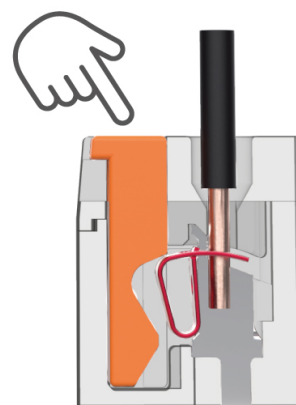

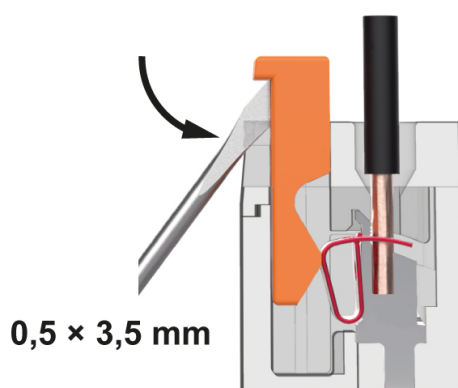
